THE TRIAL BEGAN ON MAY 7, 2007 AND IS EXPECTED TO LAST THROUGH OCTOBER 2009.

THIS INFORMATION IS INVALUABLE FOR THE ATTENDING PHYSICIAN TO GUIDE THE FAMILY THROUGH THE BEST COURSE OF ACTION. 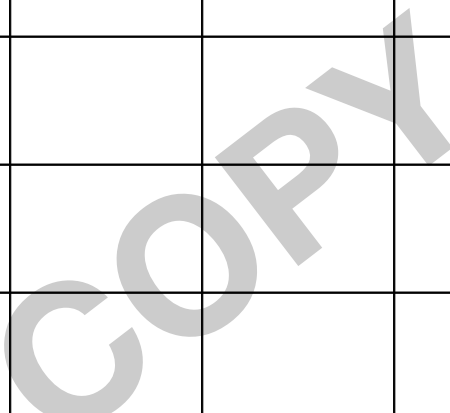
